
PRIVACY POLICY

BACKGROUND:

This Policy applies as between you, the User of this Website and abba Motorcycle Equipment UK Ltd the owner and provider of this Website. This Policy applies to our use of any and all Data collected by us in relation to your use of the Website.

1. Definitions and Interpretation

In this Policy the following terms shall have the following meanings:

“Data”	means collectively all information that you submit to the abba Motorcycle Equipment UK Ltd via the Website. This definition shall, where applicable, incorporate the definitions provided in the Data Protection Act 1998;
“abba Motorcycle Equipment”	means abba Motorcycle Equipment UK Ltd of Unit 1, 29 Cutlers Road, South Woodham Ferrers, Essex, CM3 5WA
“User”	means any third party that accesses the Website and is not employed by abba Motorcycle Equipment UK Ltd and acting in the course of their employment; and
“Website”	means the website that you are currently using (www.abbastands.co.uk)

2. Scope of this Policy

This Policy applies only to the actions of abba Motorcycle Equipment UK Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

3. Data Collected

Without limitation, any of the following Data may be collected by this Website from time to time:

- 1.1 name;
- 1.2 contact information such as email addresses and telephone numbers;
- 1.3 demographic information such as post code, preferences and interests;
- 1.4 financial information such as credit / debit card numbers;
- 1.5 IP address (automatically collected);
- 1.6 web browser type and version (automatically collected);
- 1.7 operating system (automatically collected);
- 1.8 a list of URLs starting with a referring site, your activity on this Website, and the site you exit to (automatically collected); and
- 1.9 Specific information regarding your motorcycle, including make model and

year of manufacture.

4. Our Use of Data

- 1.1 Any personal Data you submit will be retained by abba Motorcycle Equipment UK Ltd.
- 1.2 Unless we are obliged or permitted by law to do so, and subject to Clause 5, your Data will not be disclosed to third parties.
- 1.3 All personal Data is stored securely in accordance with the principles of the Data Protection Act 1998. For more details on security see Clause 11 below.
- 1.4 Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:
 - 4.a.1 internal record keeping;
 - 4.a.2 improvement of our products / services;
 - 4.a.3 transmission by email of promotional materials that may be of interest to you;
 - 4.a.4 contact for market research purposes which may be done using email, telephone, fax or mail. Such information may be used to customise or update the Website.

5. Third Party Websites and Services

- 1.1 abba Motorcycle Equipment UK Ltd may, from time to time, employ the services of other parties for dealing with matters that may include, but are not limited to, payment processing, delivery of purchased items, search engine facilities, advertising and marketing. The providers of such services do have access to certain personal Data provided by Users of this Website.
- 1.2 Any Data used by such parties is used only to the extent required by them to perform the services that abba Motorcycle Equipment UK Ltd requests. Any use for other purposes is strictly prohibited. Furthermore, any Data that is processed by third parties shall be processed within the terms of this Policy and in accordance with the Data Protection Act 1998.

6. Links to Other Websites

This Policy does not extend to your use of such websites. Users are advised to read the privacy policy or statement of other websites prior to using them.

7. Changes of Business Ownership and Control

- 1.1 abba Motorcycle Equipment UK Ltd may, from time to time, expand or reduce our business and this may involve the sale and/or the transfer of control of all or part of abba Motorcycle Equipment UK Ltd. Data provided by Users will,

where it is relevant to any part of our business so transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this Policy, be permitted to use the Data for the purposes for which it was originally supplied to us.

- 1.2 In the event that any Data submitted by Users is to be transferred in such a manner, you will not be contacted in advance and informed of the changes.

8. **Controlling Use of Your Data**

1.1 Wherever you are required to submit Data, you will be given options to restrict our use of that Data. This may include the following:

- 1.a.1 use of Data for direct marketing purposes; and
- 1.a.2 sharing Data with third parties.

9. **Your Right to Withhold Information**

You may access the Website without providing any Data at all. However, to use all features and functions available on the Website you may be required to submit certain Data.

10. **Accessing your own Data**

You have the right to ask for a copy of any of your personal Data held by abba Motorcycle Equipment UK Ltd (where such data is held) on payment of a small fee which will not exceed £
